WARNING	Any form of low-level disruption	Verbal warning from the teacher <u>Name on board or recorded</u> <u>This can come off if behaviour improves</u>
C1	Preventing the learning of others in the classroom: <ul style="list-style-type: none"> • Failure to complete tasks • Misuse of electronic equipment • Lateness • Unintentional inappropriate behaviour towards others • Low-level disruption to lesson/learning of others • Low-level challenging behaviour towards a member of staff • Lack of respect • Lack of proper equipment • Incorrect uniform • Incomplete homework 	<ul style="list-style-type: none"> • C1 if behaviour does not improve. Detention at the teacher's convenience – can be up to 15 minutes • Recorded and resolved on SIMS
C2	Repeated C1 behaviour or serious disruption: Preventing the learning of others in the classroom: <ul style="list-style-type: none"> • Failure to complete tasks • Misuse of electronic equipment • Lateness • Unintentional inappropriate behaviour towards others • Low-level disruption to lesson/learning of others • Low-level challenging behaviour towards a member of staff • Lack of respect • Lack of proper equipment • Incorrect uniform • Incomplete homework 	<ul style="list-style-type: none"> • C2 if behaviour does not improve. Detention at the teacher's convenience – can be up to 30 minutes • Recorded and resolved on SIMS
C3	Failure to co-operate with the school's Code of Conduct: <ul style="list-style-type: none"> • Repeated or serious Level 2 behaviours • Anti-social behaviour • Intentional inappropriate behaviour to others • Dangerous behaviour • Offensive language • Dropping litter 	<ul style="list-style-type: none"> • C3 Faculty detentions arranged by HOF. Teacher to contact home and actions MUST go on SIMS • First detention 30 mins. Second 1 hour • Failure to attend second detention – discussion with HOH to decide if to escalate to an internal or another HOF detention • If student is parked – automatic HOF detention • Refusal to be parked or a serious health and safety issue – call for SLT support. Discussion with HOH/HOF/SLT as to what the sanction will be
C4	<ul style="list-style-type: none"> • Abuse of property and people • Repeated serious Level 2/3 incidents • Continued inappropriate behaviour towards others • Truancy • Theft • Refusal to follow instructions/failure to co-operate (e.g. lying) 	<ul style="list-style-type: none"> • Internal isolation arranged with HOH. • Parents/carers contacted and recorded on SIMS
C5	<ul style="list-style-type: none"> • Serious abuse of people or property • Repeated or serious Level 4 behaviour • Physical violence (usually 2 days) • Threatening behaviour • Racist abuse/ homophobic language • Serious breach of health and safety • Swearing at staff • Use/possession of substances (including tobacco, alcohol, legal highs, illegal drugs) • Malicious use of electronic equipment 	<ul style="list-style-type: none"> • Fixed term exclusion agreed with SLT • Head's PA informed to generate FTX letter • Recorded on SIMS • Parents contacted • Reintegration meeting organised with member of SLT/HOH • Work booklet sent home
C6	<ul style="list-style-type: none"> • Serious abuse of people or property • Repeated Level 5 incidents • Possession of a weapon • Repeated use/possession of illegal drugs • Supply of illegal drugs • Violence towards staff 	<ul style="list-style-type: none"> • Permanent Exclusion
